Sierra Nevada Revolving Loan Fund Scope of Work

1. Introduction

1.1 Background

RCAC has been awarded a grant by the Economic Development Administration (EDA) to operate a Revolving Loan Fund (RLF) in 16 California counties in or adjacent to the Sierra Nevada region, including the five counties of the Central Sierra Economic Development District (CSEDD) served by Mother Lode Job Training (MLJT). The funding was made available through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) of 2020 and granted under the authority of the EDA's Economic Adjustment Assistance program with the goal of providing a wide range of financial assistance to communities and regions as they respond to, and recover from, the impacts of the coronavirus pandemic.

The RLF will preserve existing small businesses and provide accessible capital for new and expanding small businesses that are often overlooked by traditional lenders. Once the need for immediate support to distressed businesses has passed, RLF lending will be targeted to help advance economic diversification and resilience in accordance with goals identified in the CSEDD's 2017-2022 Comprehensive Economic Development Strategy (CEDS).

RLF funds will remain committed to the designated 16-county region to facilitate short-term recovery and the long-term development of a regional economy more resilient to future disasters and downturns. Close collaboration between MLJT and RCAC will ensure that lending supports the region's economic development, diversification, and sustainability needs.

1.2 Scope of Work

MLJT will help RCAC to connect with potential borrowers in the five counties that make up the CSEDD: Alpine, Amador, Calaveras, Mariposa, and Tuolumne; assist in developing strategies to meet the region's economic development goals; and help to measure and communicate impact.

MLJT will:

- 1. Market the availability of RCAC loans to potential borrowers.
 - Include information about the available funds on its website.
 - Refer clients to RCAC loan officers for follow-up and processing.
- 2. Assist RCAC loan officers in communications with applicants and recipients.
 - Provide technical assistance to loan applicants, including review of applicants' RCAC job tracking projection forms, as appropriate.
 - Work with RCAC Loan Fund staff to respond to borrower needs and structure loans.
 - Maintain records documenting contacts, correspondence and guidance provided to loan applicants and recipients.

- 3. Inform strategy to maximize impact.
 - Meet regularly with RCAC to coordinate compliance and monitoring efforts, ensure consistent messaging to loan applicants, and develop strategies to maximize the impact of RLF funds in its region.
 - Inform RCAC of updates to its CEDS or other regional development plans.
- 4. Help measure and communicate impact.
 - Assist loan recipients in completing RCAC job tracking sheets based on actual job retention and/or job creation.
 - Provide regular reports with funds requests to provide an overview of activities during the invoice period.
 - Highlight success stories when loans are closed with borrowers in its region.

RCAC will:

- 1. Pay up to \$20,000 to MLJT toward documented staff time and reimbursable expenses that support the functions within this Scope of Work.
 - Payment will be calculated at a maximum rate of \$130 per hour.
 - Funding will be available through the end of the award period (03/21/2024) but may be fully disbursed earlier if needed.
- 2. Manage the RLF according to an EDA-approved RLF Administration Plan that identifies lending priorities and criteria.
 - Communicate RLF lending priorities and guidelines to MLJT for its use in outreach/marketing and technical assistance to potential borrowers.
 - Present loans to RCAC Loan Committee for approval, and service loans once they are approved.
- 3. Meet EDA reporting requirements throughout the duration of the award period ending 03/31/2024.

2. Project Deliverables

- 1. MLJT will submit reimbursement requests to RCAC at least quarterly but no more than once per month until the full subaward amount of \$20,000 has been disbursed. Requests will include an invoice, source documentation, and narrative report on work with loan applicants/recipients and coordination with RCAC.
- 2. MLJT will submit a final reimbursement request and narrative report to RCAC no later than 03/31/2024.

3. Project Timeline

Implementation will begin immediately upon execution of the subaward agreement between RCAC and MLJT. RCAC may disburse the full \$20,000 during the first project year, though funds will be available through the award period ending 03/31/2024.

4. Project Budget

RCAC will provide up to \$20,000 to MLJT. This funding will be available over the three-year award period but may be disbursed within the first project year if needed. Funds will be disbursed to MLJT as individual businesses are identified for support. MLJT will document tasks performed within this Scope of Work and charge RCAC for reimbursement. See subaward budget for details.

5. Requirements (Contractor/Subrecipient)

As a subrecipient of an EDA grant awarded to RCAC, MLJT must provide proof that it is an entity eligible to receive EDA assistance, and comply with all of the terms and conditions of the award, including but not limited to the Standard and Specific Award conditions, applicable OMB cost principles, and applicable regulations at 2 CFR part 200 and 13 CFR Chapter III. EDA shall approve the subaward agreement between RCAC and MLJT, per 13 CFR 309.2. Other requirements are detailed in the subaward agreement.

Mono County Considerations

Members:

- Add just Mono County, or also Mammoth Lakes (Inc. town)?
- Add 2 board seats or 3? (Note: Amador County was added without cities)
- Currently 12 board votes amongst 7 JPA members (5 counties & 2 cities)
- Post-Mono totals: 14 or 15 votes amongst 8 or 9 JPA members
- Quorum will increase from 7 to 8 either scenario

• CEDS:

- EDA has authorized adding Mono County to the new CEDS grant
- Must apply to EDA for formal redefinition of boundaries
- Require in-kind matching contribution (\$20K/6 = \$3,333) from Mono?
- Note: Existing 5 County CSEDD members' in-kind would decrease ~16.7%

Financials:

- Add to or dilute current \$25K budget by Mono fees (~9.5%)?
- Charge prorated amount for remainder of initial membership year?

Process for Adding Mono to JPA

- 1. CSEDD Board approves intent to add Mono County to the JPA (5/20/2021)
- Mono County BOS ratifies their intent to join CSEDD JPA
- 3. 2/3 (5) of the existing 7 CSEDD members must ratify adding Mono County to the JPA
 - Boards of Supervisors and City Councils
- 4. CSEDD sends JPA modification notification to the State
- 5. CSEDD amends EDA CEDS grant to include Mono
