- 5.3. Update on Eastern Sierra K-16 Planning Grant ARCHES or Amy Frost Amy Frost shared the goals for K16 Planning Grant:
 - Increase the number of students pursuing 2 and 4 year postsecondary degrees and industry recognized credentials that will meet the region's economic and labor market needs in computing, engineering, education, and health industry sectors.
 - Increase the number of K12 pathway completers and pursuers in computing, engineering, education, and health pathways in the region.
 - Establish and grow industry partnerships that contribute to an increase in the number of K12 pathways in computing, engineering, education, and health pathways in the region.
 - Increase the number of Work Based Learning experiences for K16 students in computing, engineering, education, and health pathways.
 - Increase dual enrollment offerings for the regions K12 student population.
